Economic Returns to Skills in Kazakhstan in the Context of International Comparisons	The study examines the economic returns to literacy, numeracy and problem-solving skills in adults in Kazakhstan with the OECD data. Unlike in other countries, the returns to skills are neither economically nor statistically significant.
